## REPRESENTATIVE CASES

### **S-Bank appeal proceedings against the Finnish Financial Supervisory Authority's decision**

We represent S-Bank in multi-agency regulatory investigations and demanding appeal proceedings against a decision by the Finnish Financial Supervisory Authority, in a matter where the Finnish Financial Supervisory Authority imposed a fine and public warning on S-Bank.

### **D&I represented a Dutch LNG supplier in international energy arbitration under the FAI rules**

We represented a leading Dutch LNG supplier against a Finnish publicly owned energy company in cross-border multi-million euro arbitration proceedings under the FAI rules in a contractual dispute relating to terminal services.

### **Appeal by the electricity DSO regarding the Energy Authority's regulatory methods**

We represent Finland's largest electricity distribution system operator Caruna in demanding Market Court proceedings concerning an appeal against new regulatory methods set by the Finnish Energy Authority.

### **10 MEUR post-M&A arbitration on the acquisition of an electricity sales company**

We represented a Finnish energy corporation, electricity network operator and electricity provider, its group companies and its contractual parties in post-M&A arbitration proceedings under the FAI rules.

### **ICC arbitration on the distribution of pharmaceuticals**

We represented the Finnish subsidiary of a global pharmacy giant in their arbitration proceedings under the ICC rules of arbitration, the dispute concerning an international distribution agreement.

## **FAI arbitration regarding cancellation of purchase contract for machinery**

We successfully acted for a leading company specialising in the trade and production of steel and aluminium in an arbitration under the FAI rules concerning the cancellation of a purchase contract for machinery.

## **Dispute on EUR 80 million delivery contract and simultaneous contract negotiations**

We advised a global leading supplier of technology and automation services to the pulp, paper, and energy industries in a dispute against a major forest industry corporation arising from an EUR 80 million delivery contract. Simultaneously, we advised our client in contractual negotiations relating to a new framework agreement for future projects between the same parties. The case was successfully settled before arbitration, and a new framework agreement was put in place between the parties.

## **Outsourcing of IT-business – 20 MEUR cross-border FAI arbitration**

We represented our client in EUR 20 million FAI arbitration concerning outsourcing of digitalizing services that were vital for the continuance of the client's operations and business.

All our client's claims were accepted in their entirety, including compensation for indirect damage (loss of business).
